Upcoming Issues to Note

TLS Cryptographic Protocol Support

Read the following to avoid service disruptions.

TLS is a cryptographic protocol that provides authentication and data encryption between different endpoints (for example, the user's desktop and the application server). Various vulnerabilities (such as POODLE and DROWN) have been found in TLS versions 1.0 and 1.1 in recent years.

As announced in the latest security update, to avoid security vulnerabilities and to align with industry standards, Ex Libris will block TLS 1.0 and 1.1 traffic for Alma API in production environments and will support only TLS 1.2. The deprecation plan which was communicated will begin by October 2021 and will be concluded by May 2022:

- Canada – October 17, 2021
- APAC – February 20, 2022
- Europe – March 10, 2022
- America – May 15, 2022

SAML Certificate Workflow Update

Starting in August 2021, to accommodate the updated expiration policy of the certificate vendors, the signed certificate will be issued twice yearly.

For example, the certificate made available in August 2021 will expire in June 2022 and the certificate made available in February 2022 will expire in December 2022. This means that institutions that wish to use the signed certificate must update it twice a year.

Ex Libris highly recommends using the provided self-signed certificate to reduce the frequency of certificate updates.

Vendor-Controlled PO Line Renewal - EBSCO

May 2022 Acquisitions

EBSCO now supports Vendor-Controlled Renewals that enables customers to renew subscriptions within EBSCONET and have the matching continuous PO line in Alma renewed automatically. This integration enables EBSCONET to automatically update a PO line once a subscription is renewed and as a result, save duplication of work for the user. This integration joins the existing ProQuest RenewMe integration for subscription renewals.

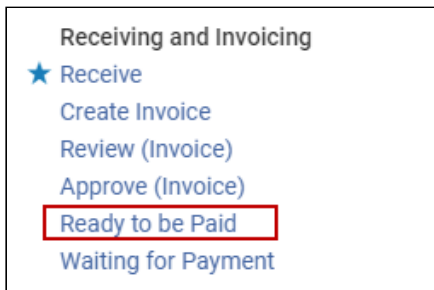

An option to present the "Note to vendor" is added to the file exported to Excel when exporting a list of PO lines (Export all fields). This enables users to review PO lines more efficiently.

Alphabetical Sorting of Libraries in GetIt - Support for Languages

May 2022 Administration and Infrastructure

Previously, sorting of the item list in the GetIt section in Primo is by one of the following options:


- Priority (based on a number of available items per library) – default option
- Alphabetically
- Custom

In cases where the Alphabetical sorting was selected and there are diacritics in the location name that the item belongs to, this does not come into consideration.

Now, when the sorting is configured to be Alphabetical [[Alma Configuration > Fulfillment > Discovery Interface Display Logic > Locations Ordering Profile > Use Alphabetical Sorting Only = Yes](#)], Alma uses the UI interface language to determine whether diacritics should be handled when sorting Alphabetically the item list in the GetIt section.

Note

In cases where there is no 'special' diacritics handling for the selected language, the fallback behavior (sorting by priority) remains.

Work-Order-Type Name - Support Multiple Translations

Previously, Work-Order-Type names had a single monolingual field for their name. As a result, it is not possible to provide a translation for these labels. Now, Alma enhanced its capabilities to define language variants for the names of Work-Order-Types. The enhancements include:

- An added language (globe) icon for the **Work-Order-Type** field.
- Based on the current language of the staff or patron, the relevant value is displayed.

Note

This enhancement is only relevant when multiple languages are defined for an institution.

Improvements in Import Code Tables

The importing and exporting of code tables is improved with regards to handling of translations for such tables. The improvements include:

- Making the export sensitive to the language.
 - Having the Header of the column include the language.
 - Full support for fixed-rows code tables and making them available for all relevant code tables.

Form Based Indication Rules for Refining Repository Search Results by MARC Tags and Subfields

NERS Enhancement (ID #6795)

It is now possible to create indication rules using a structured form, thus making the process easy and intuitive. The new format enables entering the different fields and subfields and values in a wizard-like fashion, and provides popup assistance when entering tags and tag names. This is especially useful for users who are not experts in cataloging. Relevant use cases: Refining a set of records using values that are not part of the pre-defined index.

Note

For UNIMARC/CNMARC, control fields work as text fields. Ex Libris plans to support working in the control tokens in a later release.

Set Unavailable Physical Items Process Types

NERS Enhancement (ID #7177 7350)

Library staff now have better control over process types: placing and removing institution-level work order types using the **Change Physical items information** job, searching by work order type and excluding a specific work order type from discovery. The work order types were enhanced to streamline workflows, allowing handling in bulk and without scanning items in. This is especially useful when the library needs to mark a large set of items as unavailable in a way that's reflected in discovery, such as due to renovations or COVID restrictions.

Example use case:

A room in the library has to be closed due to mold. Now staff can:

1. Create a work order type called **mold cleaning** (configuration is minimal: Alma automatically generates a work order department, which the institution can select to use/ignore/change as needed).
2. Create a set of all items in the room.
3. Run a job to add the new work order type to all the items. This is immediately reflected in Get It (using the work order type label, which OTB is displayed as **"In process of {mold cleaning}"**).
4. Once the mold issue is resolved, run the job again to remove the work order and make the items available again.

After adding a new work order type, please log out and log in again in order to make the [Physical Item Search > InProcess](#) index's drop down to be refreshed.

Batch Update Electronic Collection Attributes (NERS 6969)

NERS Enhancement (ID #6969)

With this new functionality, library staff can update attributes of a set of electronic collections in batch using a dedicated job. Library staff can select which attributes to update and under which conditions.

This functionality is useful for various use cases such as:

1. A vendor announces platform maintenance that will make the platform inaccessible for several hours. There is a need to batch-apply to all the collections on that platform the same **Authentication Note** stating that the platform is unavailable. Then, when the maintenance is over, there is the ability to batch-remove the same note.
2. A vendor announces that the URL syntax is changed. There is a need to batch change the Electronic Collection Level URLs.
3. Update electronic collections to use the same proxy sever.

New field '**COUNTER Platform derived from Interface**' for Future Optimization of Cost/Usage Reports

The **COUNTER Platform derived from Interface** field is displayed in the Electronic Collection Editor and the Electronic Portfolio Editor. The field is a read-only field and is displayed in the 'General' tab of the Electronic Collection/Electronic Portfolio. Content of the field includes the Counter Platform for the resources and is calculated based on the Interface of the electronic resource to which it belongs.

How will this information be used?

In an upcoming release the **COUNTER Platform derived from Interface** will be used in the following way:

For cases in which there is more than one COUNTER report for the same resource, Alma uses the 'COUNTER platform' set by the library at the level of the electronic collection/portfolio. If it is not defined, Alma **will** use the value in the **COUNTER Platform derived from Interface** field.

Disable Item Description Confirmation Message

The confirmation message “The description may need to be updated as well (using the generate button)” was improved to only show when relevant fields were changed and the description was not generated or updated manually. Customers who never require a reminder for updating the description are able to disable it completely.

Local Call Number and Other Classification Number Now Displayed in All Titles Search Results

You can now configure the **Local Call Number** and **Other Classification Number** to appear in the brief search results of an All Titles repository search. To configure this feature, select the configuration icon from the search results page and select **Local Call Number** and **Other Classification Number**.

Exporting Bibliographic Records and Portfolios Now Includes Network Zone Resources

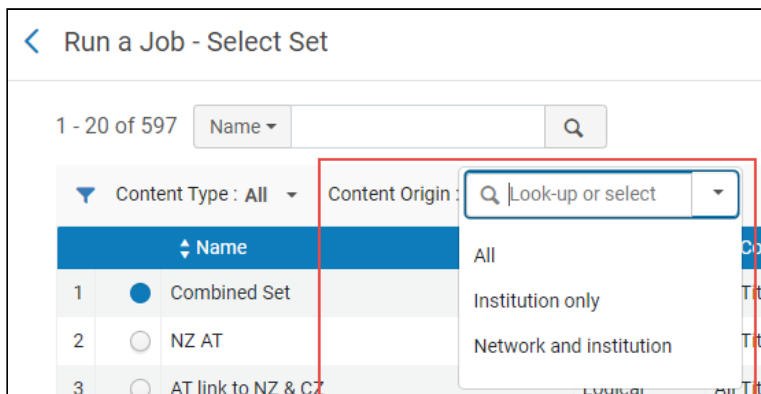

Members of consortia can now include bibliographic records and portfolios that are managed on their behalf in the Network Zone in export processes. This new functionality enables the sharing of library resources with third-party systems.

The Export Electronic Portfolios and Export Bibliographic Records manual jobs (**Admin > Manage Jobs and Sets > Run a Job**) support exporting sets that consist of combined Institution Zone and Network Zone bibliographic/portfolio records.

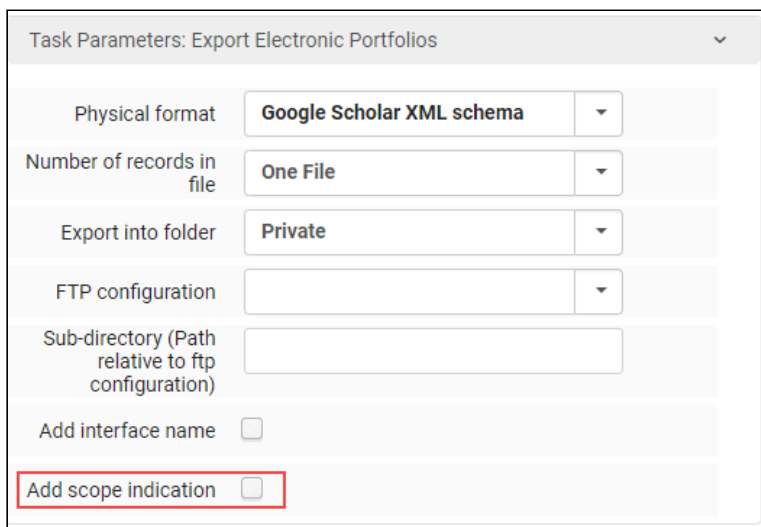
Members of consortia can create sets of records combined from the Institution Zone and the Network Zone (see [Combining Institution and Network Zone Search Results](#).) These sets can now be exported. To support this feature, the new

Content Origin drop-down list was added to the List of Sets page that enables you to display sets whose members come from the Institution Zone, a combination of both the **Institution** Zone and **Network** Zone, or **All** records.

In addition, when exporting combined sets with the Export Electronic Portfolios job, the new **Add scope indication** task parameter is now available:

Select this option to include the Institution code or the Network institution code of the electronic portfolio in the export file.

Note

The export bibliographic records job handles the Network Zone records as if they were exported directly from the network, for example – the network MMS_ID is put in the 001 and 035 fields.

Collection Internal Description Now Available for Publishing

You can now configure the general publishing profile (**Resources > Publishing > Publishing Profile**) to enrich the

bibliographic record with the collection internal description when publishing. This information can be useful for sharing internal information with third-party systems.

To support this feature, the **Collection Internal Description subfield** field was added to the Publishing Profile Details page. Indicate the subfield to which you want the collection internal description added to in the bibliographic record.

In addition, the existing **Internal Description subfield** field was renamed to **Portfolio/Service Internal Description subfield** to distinguish it from the **Collection Internal Description Subfield** field.

Currently, inventory operators can search for items according to process type, but couldn't distinguish between the different custom-defined "In Process Types" (work orders). Now, a new index is added for physical items with the "In Process Type" enabling operators to commence such searches.

Support Overlay for MODS Import

You can now configure digital import profiles ([Resources > Import > Manage Import Profiles](#)) to overwrite existing bibliographic records when the imported record matches a record already in the repository. To support this enhancement, the **Overlay** option was added to the Match Actions section of the Match Profile tab. Select this option to have Alma overwrite the existing record with the new one.

Additionally, the **Do not Override Originating System** option was added. Select this option to maintain the originating system of the original record when it is overwritten by the new record.

The following fields were added to Titles > Title Measures. They indicate the number of titles that were linked to the Community Zone or Network Zone or not linked to either:

The **Role Product** field was added to Users > Role. It indicates the specific Ex Libris product for which the role is assigned.

Alma May 2022 Resolved Issues

- **May 2022 Acquisitions SF: 05302270**
Irregular behavior when trying to link item to PO line. This was fixed and the error message was updated to reflect the correct error.
- **May 2022 Acquisitions SF: 06223146 06216859**
It was not possible to add a PO line as an additional PO line of type **license upgrade** when ordering from an electronic collection. This was fixed.
- **May 2022 Acquisitions SF: 05324591**
When sending a query from a purchase request, the email addresses are free text fields. Trying to add multiple emails to the CC field results in an error when sending the message. This was fixed by splitting CC values and creating an email receiver for each one.
- **May 2022 Acquisitions SF: 05319063**
When saving a PO line, there was no verifying if the transaction fields were changed. This was fixed. There is a verification if the transaction fields were changed and if so, there are validations and updates on the transactions.
- **May 2022 Acquisitions SF: 06049035**
Staff creating a PO line is able to see and use vendors and funds not available for the owning library of the PO line, or for the staff user's roles. This was fixed.
- **May 2022 Acquisitions SF: 05321261**
Resource in **License Inventory** tab throws an error when clicked. This was fixed.
- **May 2022 Acquisitions SF: 05323150 06040787**
Saving changes in vendor and/or vendor accounts did not index the related PO lines in SOLR. This was fixed.
- **May 2022 Acquisitions SF: 05322661**
In EDI orders, the ISBN was not added to the EDI message when there was a trailing space character at the end. This was fixed.
- **May 2022 Acquisitions SF: 06040740**
Error is thrown when trying to manually upload a SUSHI file even after splitting it. This was fixed.
- **May 2022 Administration and Infrastructure SF: 05301641**
When running **Users SYNCHRONIZE** job on an existing user, the create date value was incorrectly modified. This was fixed. The create date is now kept as is, only the milliseconds are being set to zero. The same happens for an IZ user being updated from NZ (centralized job).

A Purchase Request in status Rejected blocks deleting user via API. This was fixed and no error is thrown when a requester is; 'not exist/deleted.'

In **Manage Patron Services > Add / Renew Patron Role**: The confirmation message Old Expiration Date was misleading. This was fixed and now the message reads **Current Expiration Date**.

The Network SAML profile has been updated to use the new certificate, but the changes are not distributed successfully to the Institution Zones. This was fixed and SAML Profiles are now distributed to network members.

In Firefox, the **Holdings** text expands beyond the frame and screen. This was fixed.
- **May 2022 Administration and Infrastructure SF: 05313681**
When selecting an item from the Monitor Requests and Item Processes that is in transit, the value **Transit for reshelving** under the Request Type column is not translated. This was fixed.
- **May 2022 Administration and Infrastructure SF: 06263316**
Location names are translated, but fail to appear in Alma facets that still display the default English name even when the language is changed in the UI.

- **May 2022 Administration and Infrastructure SF: 06263235**
The card renewal fee type was explicitly set to 'lower case'. This is now fixed and Alma does not modify the case in which the type appears.
- **May 2022 Administration and Infrastructure SF: 05328280**
When the XML of the samples used for configuring letters was downloaded, the file didn't have the XML extension. This was fixed.
- **May 2022 Fulfillment SF: 05314834**
Fulfillment network requests on the expired hold shelf were sometimes not put into transit back to the home institution when the **Transit** button was clicked. This happened for example when the item had a fulfillment note. This was fixed.
- **May 2022 Fulfillment SF: 05332794**
In a fulfillment network, returning an item from a different institution that had an expired hold request created a transit loop instead of closing the request and sending the item back to its home institution. This was fixed.
- **May 2022 Fulfillment SF: 05316587 05308273 05320447**
When scanning multiple items using an RFID pad, Alma displayed the same title for all of them. This was fixed.
- **May 2022 Fulfillment SF: 05319670**
Traditional Chinese characters were garbled in the **Work Order Type Name** field and in the header of the Work Order Type Statuses page. This was fixed.
- **May 2022 Fulfillment SF: 06254953**
