Upcoming Issues to Note

SAML Certificate Workflow Update

Starting in August 2021, to accommodate the updated expiration policy of the certificate vendors, the signed certificate will be issued twice yearly.

For example, the certificate made available in August 2021 will expire in June 2022 and the certificate made available in February 2022 will expire in December 2022. This means that institutions that wish to use the signed certificate must update it twice a year.

Ex Libris highly recommends using the provided self-signed certificate to reduce the frequency of certificate updates.

Alma September 2022 Resolved Issues

September 2022 Acquisitions SF: 06340297

In certain interface languages, when a user selected the **Approve** and **Order** option in a purchase request, the PO-line link was missing from the pop-up window that opened. This has been fixed: the PO-line link appears in the pop-up window in all supported interface languages."

- September 2022 Acquisitions SF: 06405670
 The Note to Vendor field was not displayed in the PO-line list for electronic PO lines. This was fixed: the Note to Vendor field now appears in the PO-line list for all types of PO lines.
- September 2022 Acquisitions SF: 05325907 06271550 05317796 06329721 EDI invoices lines were created in the institution scope, making it impossible for a user with a role in the library scope to edit them. This was fixed: invoice lines are now created in the library scope.

This has been corrected: even if a PO is missing these addresses, the receiving process is completed successfully.

 When two work-order departments had the same code in different scopes, for example, library A and library B, deleting the circulation desk from one of the scopes caused the receiving-operator roles from the other scope to be removed from all users who had them.  After running the User Synchronization job, the expiration date that appeared in the User Details General Information was updated correctly but the expiration date that appeared in the History tab was not. This was fixed; the correct date now appears in the History tab.

 When an external user account is opened for update, an Open for Update message appears, warning that the changes will be overwritten at the next synchronization, but giving the option of protecting a specified list of fields from being overwritten. Previously, when a user generated a query to a patron for a borrowing request, and while doing so, a new borrowing request was created in Primo, the query to patron action was performed on the wrong request. This was fixed; even if new borrowing requests are created while a user is generating a query to a patron about an existing borrowing request, Alma generates the query for the borrowing request that was originally selected by the user.

Previously, when an Alma institution sent a renewal request to an NCIP-P2P non-Alma partner, and the lending institution responded to the request, in some cases the borrowing request at the Alma institution was not updated correctly. This was fixed; the information is now updated correctly in Alma borrowing requests when a response to a renewal request is received from an NCIP-P2P non-Alma institution.

Previously, when a local request was converted to a resource-sharing request, existing patron notes were not moved to the Request Note field of the resource-sharing request. This was fixed; existing notes are now transferred correctly when local requests are converted to resource-sharing requests.

 Previously, when a resource-sharing item was returned, both a transit letter and a resource-request letter were printed.

When using the API POST command to create users, if two users are created with identical identifiers at exactly the same time, the system does not recognize that the identifiers are duplicate. A new Customer Parameter, block_user_creation_multi_thread, was created to prevent this from happening. Customers who use the create-user API in parallel mode without populating the primary identifier in the payload, can prevent user duplication by setting the value of block_user_creation_multi_thread to true.
