Exercise 1: Compare a CZ Collection to All of IZ

This exercise explores Use Case 1: Considering subscribing to a package

- 1. In Alma, open Resources menu and select Overlap and Collection Analysis
- 2. Select New Analysis > Compare Collections
- 3. Change Report Title from "New Report..." to whatever you want. For example: Use Case 1.
- 4. Enter a **Description**. For example, "Compare potential new collection from Elsevier with all of IZ."
- 5. In the Compare Collections section, select **Choose the collection**
- 6. Search the **CZ** for an electronic collection to which you do *not* subscribe.
- 7. Click **Select** on your chosen collection
- 8. Compare with collections from: Entire Institution Zone
- 9. Select Match Method as needed
- 10. Select check box to Include date coverage
- 11. Choose Reference Year for embargo dropdown as needed.
- 12. Click Generate
- 13. Wait for the report to complete.
- 14. Click View Report
- 15. Click the download button if for any title lists you want to see in more detail.
- 16. Open the downloaded file in Excel or the spreadsheet program of your choice.
 - a. Scroll through the file to see information about the titles, including the Collection each title is in.
 - b. Select the second tab, **Analysis Information**, to see information about the Overlap Analysis job.



Exercise 2: Compare an IZ Collection to All of IZ

This exercise explores Use Case 2: Considering unsubscribing (cancelling) a package

- 1. In Alma, open Resources menu and select Overlap and Collection Analysis
- 2. Select New Analysis
- 3. Choose Compare Collections
- 4. Change **Report Title** as desired. For example, "Use Case 2."
- 5. Enter a **Description** as desired. For example, "Analysis to consider cancelling [name of collection]."
- 6. Select Choose the collection
- 7. Search the Community Zone for the collection you're considering cancelling
- 8. Click Select
- 9. Select Compare to Entire Institution Zone
- 10. Select Match Method as appropriate for the resources in the collection
- 11. Select check box for **Include date coverage** if needed (for example, for a serials collection)
- 12. Click Generate
- 13. Wait for the report to complete.
- 14. Click View Report
- 15. Scroll down to look at the Analysis Report section
- 16. Scroll down to look at the **Analyzed Collection** section
- 17. Download any title files that you'd like to look at.
- 18. Review downloaded files as needed.



Exercise 3: Compare a List of Titles to All of IZ

This exercise explores Use Case 3: Considering purchasing a set of titles from a vendor, based on the vendor's title list.

- 1. In Excel or another spreadsheet program, open the file of titles received from the vendor.
- 2. The file must follow parameters shown in this document in the Ex Libris Knowledge Center:
 - a. The cell in the first row and first column of the spreadsheet (Cell A1) must contain the title identifier that is used in the table. It must be one of the following types of identifiers:
 - i. eISSN/ISSN
 - ii. eISBN/ISBN
 - iii. LCCN
 - iv. Title
 - b. The identifier for each title must appear in the remaining rows of the first column of the spreadsheet.
 - c. Other columns of data can be included (for example, Title, Coverage, etc.) and will appear in the results files if the column also has text in the header (Row 1).
 - d. Each row of the spreadsheet should contain only one title.
- 3. In Alma, open Resources menu and select Overlap and Collection Analysis
- 4. Select New Analysis
- 5. Choose Look Up Titles
- 6. Enter a Report Title of your choice. For example: "Use Case 3"
- 7. Enter **Description** of your choice. For example: "Compare vendor title list to all of IZ"
- 8. Drag and drop the vendor's title file from your computer onto the page in the **Upload input file** section:

Drop a file or Select or drag an Excel File (.xlsx or .xls)

- 9. Select box for Institution Zone Electronic Resources
- 10. Choose report format output. For example, "One excel line per match"
- 11. Click **Generate**
- 12. Wait for the report to be completed.
- 13. Click View Report
- 14. Download any title files that you'd like to look at.
- 15. Review downloaded files as needed.
 - a. Review the content of the various tabs in the spreadsheets
