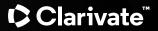



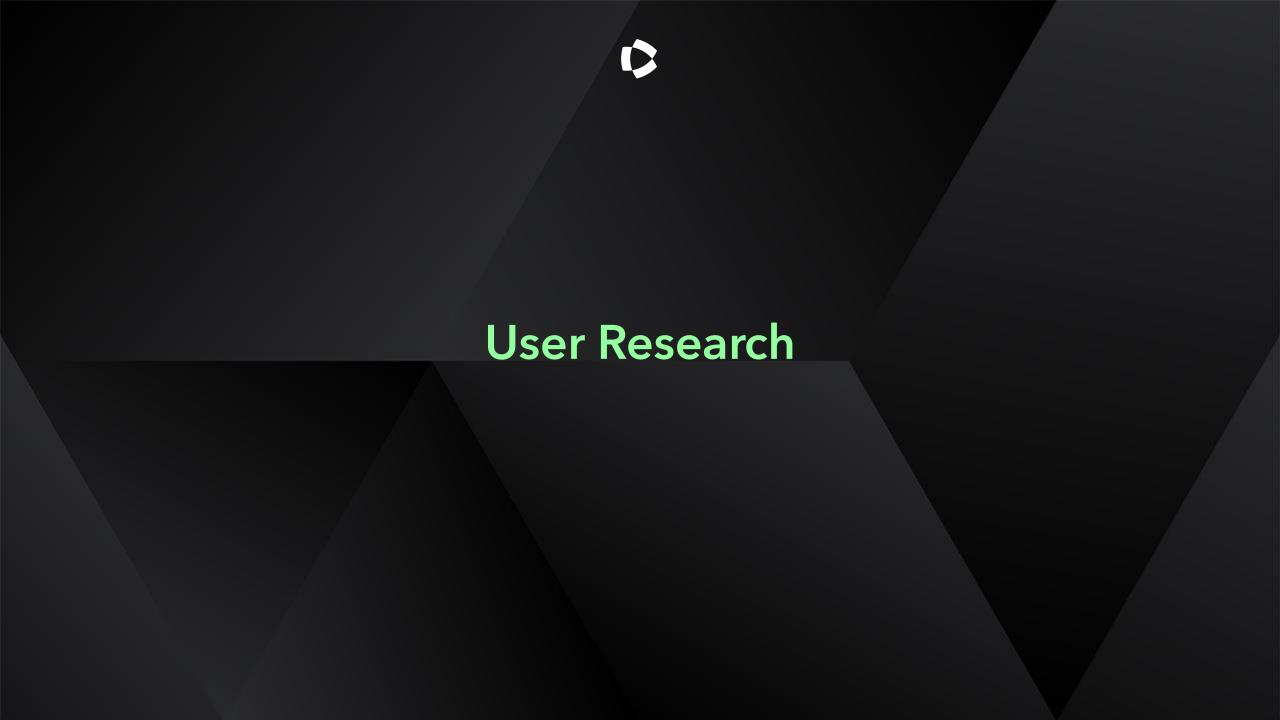

Collaboration With Users

In-App & Social Media User Survey

Launched survey January 23

Followed up with every responder who provided contact information

- We asked: How would you like to help?
 - 51% of responders want to get involved in at least 1 way;
 - Additional 24% of responders would like to participate in multiple ways

Asked opinion and engagement questions:

- How likely are you to recommend RefWorks?
 - 78% responded favorably, 87 provided contact info for further engagement.
 - 22% who were not completely satisfied, 19 provided contact info.
- What's your current role?
 - 27% of responders are post-graduate
 - 22% graduate
 - 21% undergrads and rest are other: librarians, professionals and researchers

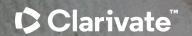
