

Updated Analytics Tables

Alma October 2023 Resolved Issues

October 2023 Acquisitions SF: 5299957

When a hold request from an interested user was added to the queue, it was incorrectly added at the end of the queue. This was because other requests that should have a lower priority had already been activated in the queue. The order in which these processes are performed was reversed so that interested users are entered into the queue before activation takes place and are thus given the correct priority in the queue.

- October 2023 Acquisitions SF: 6734801
 There was a problem when trying to add funds when the fund code contained only numbers. This was fixed.
- October 2023 Acquisitions SF:6702686
 Until now, it was possible in Alma to create two invoices for the same supplier with the same invoice number. This was fixed. Now, when the customer parameter "invoice_not_unique" is false, it is impossible to duplicate the invoice number of the same supplier.
- October 2023 Acquisitions SF:6629131
 Past funds were accessible in the recent funds drop-down list when creating PO lines. This was fixed. Now, if the user has a previous fiscal year fund, when selecting "Save and Continue" or "Order Now", a message is displayed that the fund is not in the current fiscal year.
- October 2023 Analytics SF:6711398
 Usage data from several SUSHI files did not appear in Analytics. This was fixed.
