## **Before You Begin**

#### **Logging In**

The procedure for logging in is shown in <u>Procedure 1-1</u>, <u>Logging In</u>, on page <u>1-2</u>.



#### Procedure 1-1. Logging In

Use the following to log in to Voyager Media System Administration.

 Double-click the Media System Administration icon on your desktop from the Start menu.




Figure 1-1. Media System Administration Login Dialog Box

Result: The Login dialog box displays. See Figure 1-1.

- 2. Enter your ID and Password.
- 3. Click the **OK** button.

Result: The Media System Administration workspace displays.

Once you successfully log in to the Media System Administration module, you can begin to configure your policies and enter the information needed to control Media Scheduling activities.

You can get help about Media System Administration by pressing **F1**. For more detailed information, the following items are available on the **Help** menu.




Figure 1-2. Media System Administration Login Information Dialog Box

# **Using Media System Administration**

#### Introduction

The Voyager Media System Administration module offers a wide variety of options for configuring Voyager Media Scheduling to reflect your library's situation and policies. You should decide with your colleagues what options fit your circumstances and what policies you want to encode into the system. This allows you to configure Voyager Media Scheduling so that you can take full advantage of its power and flexibility.

No matter what kind of system you are coming from or whether you have previously used a paper system to track your media scheduling activities, your implementation can be as simple or as complex as your library policies. As you and your colleagues begin discussions about the various decisions you must make, this may be an excellent opportunity to rethink some policies and procedures to reduce complexity and thereby streamline your workflows. A paper-based media scheduling process, for example, involves certain activities that are not required by a computerized system and may be eliminated from your current procedures.

You can also make changes to Voyager Media System Administration once you learn more about the system and have some first-hand experience with using the Voyager Media Scheduling module.

#### **Operator Security**

The **Operator Security** list bar button (<u>Figure 2-3</u>) provides access to options that determine what permissions Voyager users have within Media Scheduling.

Operator Security

Figure 2-3. Operator Security Tab

You can control the following separate aspects of security.

- The information that is accessible.
- The people that can access it.
- What locations can be accessed.

Each operator who uses Voyager Media Scheduling must have an Operator Profile containing a name, Operator ID, and Password. Before using staff-side Voyager Media Scheduling, operators must login by typing in their Operator ID and Password. The link between an Operator Profile and a Security Profile lets the system know what functions the operator can and cannot perform in the Voyager Media Scheduling module.

#### **Entering Information**

When operators log in to the Voyager Media Scheduling module, they must type in their Operator IDs and Passwords exactly as they are entered here, including upper and lower case alpha characters, or their sign-on attempt is rejected. For example, if you enter "mEdia" as an Operator ID and Password the system rejects "media" or "Media" or any other variant typed at login. The system accepts only "mEdia."

#### **Security Profiles**

The settings in the Security Profile (Figure 2-6) determine, for anyone who is a part of that Security Profile, what types of activities can and cannot be performed.

See <u>Security Profiles and Policy Groups</u> on <u>page A-1</u> for a description of the relationship between Security Profiles definitions and Policy Groups definitions as it relates to operator authorizations for **Bookings** and **Inventory**.




Figure 2-4. Operator Security-Security Profiles

The procedure for creating a new Security Profile Name is shown in <u>Procedure 2-2</u>, <u>Creating a New Security Profile Name</u>, on page <u>2-3</u>.



#### Procedure 2-2. Creating a New Security Profile Name

Use the following to create a new Security Profile Name.

1. Click the **Security Profiles** button (Figure 2-5) located on the Operator Security tab.

2. Click the New button.

Result: The Security Profiles Settings dialog box displays.

#### **Security Profile Settings**




Figure 2-6. Security Profile Settings Dialog Box

The **Security Profiles Settings** dialog box (<u>Figure 2-6</u>) is where you name and create a security profile that can be used in the Voyager Media Scheduling module.

#### **Operator Security Profile Settings**

The **Security Profile Settings** dialog box allows you to configure the security settings for viewing, adding, updating and deleting the Voyager Media Scheduling equipment, equipment maintenance, room, item, patron, and booking records. The settings made in this dialog box are applied to the operator security profile currently being edited.

The levels of security shown in <u>Table 2-1</u> on <u>page 2-4</u> can be set individually for Equipment, Equipment Maintenance, Rooms, Items, Patrons, and Bookings.

**Table 2-1.** Security Levels

#### **NOTE:**

In order to view historical bookings, you must also have the Retain Patron ID for Media Booking History box checked. This retains a link between items and patrons in the Voyager Media Scheduling module. If this checkbox is not set, historical bookings does not record which patron charged which media items. See the System Administration User's

Guide for more information.

#### Locations




Figure 2-7. Operator Security-Locations

The **Operator Security - Locations** dialog box (<u>Figure 2-7</u>) provides options that you select to determine which groups of people by location have permissions to to execute different functions based on the settings (as saved in **Operator Security - Security Profiles**) for that group.

The procedure for editing location assignments is shown in <u>Procedure 2-3</u>, <u>Edit</u> <u>Location Assignments</u>, on page 2-7.



#### **Procedure 2-3. Edit Location Assignments**

Use the following to edit location assignments.

1. Click the **Locations** icon (Figure 2-8) located on the **Operator Security** list bar.



Figure 2-8. Locations Button

Result: The Locations workspace displays.

#### **NOTE:**

The list of location names that displays is dependent on the locations created in Voyager System Administration in **System** > **Locations**.

2. Select a location from the Location Name list and click Edit.

Result: The **Change Location Assignments** group box displays, and the name of the currently selected location is highlighted. See <u>Figure 2-9</u>.



Figure 2-9. Change Location Assignments group box

3. Check every box for every profile to which you want to allow access to the selected location.

Result: This identifies the operator group permissions for each location.

#### NOTE:




Figure 2-10. Voyager System Administration OPAC Circ Desk example

To enable media booking requests through WebVoyáge, at least one of the operator groups must have permissions granted for the location identfied in Voyager System Administration as the default **OPAC Circ Desk**. See <u>Figure 2-10</u>.

4. Click the **Close** button when you are done making changes.

Result: This saves the option(s) that you selected

#### NOTE:

Any changes that you make take effect immediately. However, you may experience a lag between saving these options and the change taking effect while Voyager executes the change.

#### **Operators**

The **Operators** workspace (<u>Figure 2-11</u>) lets you assign a security profile to each operator. Operators can be created and deleted only through the main Voyager System Administration module. You may assign only one profile to each operator.



Figure 2-11. Operator Security-Operators

The procedure for editing an Operators group is shown in <u>Procedure 2-4</u>, <u>Editing an Operators Group</u>, on page <u>2-10</u>.



#### Procedure 2-4. Editing an Operators Group

Use the following to edit an Operator's group.

1. Click the **Operators** button (<u>Figure 2-12</u>) on the **Operator Security** tab.

- 2. Select an operator from the list.
- 3. Click Edit.

Result: The Change Operator Assignment dialog box displays.

- 4. Select a security profile from the Security Profile Name list.
- 5. Click Save or click Cancel.

Result: This saves or discards changes.

# **Media Scheduling**

The Media Scheduling portion of the Voyager Media System Administration module allows you to configure the information you need for using your Voyager Media Scheduling module. You can create and edit different categories or "types" of items, rooms and details that you can then use to keep your inventory in order and process bookings more swiftly. You can use these to highlight important information that might be necessary to complete a booking.

Click the **Media Scheduling** listbar (<u>Figure 2-13</u>) to display the icons for the tools on the taskbar.

#### **Equipment Types**




Figure 2-14. Media Scheduling-Equipment Type Window

The Media Scheduling-Equipment Types window (<u>Figure 2-14</u>) is for entering your equipment type descriptions and codes to identify the kinds of equipment you are charging in your Media Scheduling sessions and all of the different equipment that is available to the patrons. This tool also allows you to create Equipment Groups Types, so that you can also assign Equipment Groups with identical types of equipment to the same group.

To access the Media Scheduling-Equipment Type window, click the **Equipment Types** button (<u>Figure 2-15</u>).

#### **Creating a New Equipment Type**

The procedure for creating a new equipment type is shown in Figure 2-5.



#### **Procedure 2-5. Creating a New Equipment Type**

Use the following to create an Equipment Type.

1. Click the New button.




Figure 2-16. Media Scheduling-Equipment Types (New)

Result: The **New Equipment Type** portion of the window displays (<u>Figure 2-16</u>).

- 2. Enter the media type description in the **Type Description** field.
- 3. Enter the code for the media type in the **Type Code** field.
- 4. Click the "**Is this a group**" checkbox if the type is going to refer to an equipment group.

If the type is to refer to a kind of equipment, do not select the check box.

5. Click **Save** to save your changes to the database, or click **Cancel** to exit without saving.

#### **Editing an Equipment Type**

The procedure for editing an equipment type is shown in <u>Procedure 2-6</u>, <u>Editing</u> an Equipment Type, on page 2-14.



#### Procedure 2-6. Editing an Equipment Type

Use the following to edit an Equipment Type.

- 1. Click an **Equipment Type Description** to highlight it.
- 2. Click the Edit button.

Result: The Edit Equipment Type portion of the window displays.

- 3. Place your cursor in the **Type Description** field and re-type any information that you want to change.
- 4. Place your cursor in the **Type Code** field and re-type any information that you want to change.

#### **NOTE:**

When editing an equipment type, the group or item condition cannot be changed.

5. Click **Save** to save your changes to the database; click **Cancel** to exit without saving.

#### **Deleting an Equipment Type**

The procedure for deleting an Equipment Type is shown in <u>Procedure 2-7</u>, <u>Deleting an Equipment Type</u>, on page <u>2-15</u>.



#### Procedure 2-7. Deleting an Equipment Type

Use the following to delete an Equipment Type.

- 1. Click a Type Description to highlight it.
- 2. Click the **Delete** button.

Result: The Delete Equipment Type dialog box displays.

3. Click **Yes** to delete the Equipment Type; click **No** to retain the Equipment Type.

#### **Media Types**




Figure 2-17. Media Scheduling-Media Types

The Media Types workspace (Figure 2-17) is for entering descriptions about the media types that your patrons use and to assign a unique code to each Media Type.

Use the following to enter a media type.

1. Click the **New** button.

Result: The New Media Type fields display.

- 2. Enter the name for the type of media that you are creating in the **Type Description** field.
- 3. Enter the code for the type of media that you are creating in the **Type Code** field.
- 4. Click the **Save** button to save your information to the database; click **Cancel** to exit without saving.

#### **Editing a Media Type**

The procedure for editing a Media Type is shown in <u>Procedure 2-9</u>, <u>Editing a Media Type</u>, on page <u>2-17</u>.



#### Procedure 2-9. Editing a Media Type

Use the following to edit a Media Type.

- 1. Click a **Type Description** to highlight it.
- 2. Click the **Edit** button.

Result: The Edit Media Type workspace displays.

- 3. Place your cursor in the **Type Description** field and re-type any information that you want to change.
- 4. Place your cursor in the **Type Code** field and re-type any information that you want to change.
- 5. Click **Save** to save your changes to the database, click **Cancel** to exit without saving.

#### Deleting a Media Type

The procedure for deleting a Media Type is shown in <u>Procedure 2-10</u>, <u>Deleting a Media Type</u>, on page <u>2-17</u>.



#### Procedure 2-10. Deleting a Media Type

Use the following to delete a Media Type.

- 1. Click a **Media Type Description** to highlight it.
- 2. Click the **Delete** button.

Result: The Delete Media Type dialog box displays.

3. Click **Yes** to delete the Media Type; click **No** to retain the Media Type.

#### **Maintenance Types**

The Media Scheduling Maintenance Types activity (<u>Figure 2-19</u>) allows you to enter all of the kinds of maintenance you perform on your Media Scheduling items and everything that is associated with those items such as rooms and storage areas.




Figure 2-21. Media Scheduling-Media Room Types




Figure 2-23. Media Scheduling-Media Room Detail Types




Figure 2-25. Media Scheduling-Policy Settings Window




Figure 2-28. Equipment Matrix Settings dialog box




Figure 2-29. Item Matrix Settings dialog box




Figure 2-30. Item Status Alerts tab




Figure 2-31. Item Status Alerts Example




Figure 2-34. Policy Group Settings

Place a check in the **Shorten at Close** box in order to specify that for delivery bookings, where the time until closing is earlier than the time that the booking would normally be due, should be set to expire at closing. An empty checkbox indicates that the booking should roll over till the next morning.
- b. Place a check in the **Accrue Fines and Fees** box to designate whether overdue deliveries accrue fines and fees.

#### 6. In the Patron Pickup Rules section:




Figure 2-35. Calendar Settings




Figure 2-36. Locations Settings

- 15. Enter the time that it takes to shelve items at this location by clicking the up/down arrow buttons next to the digit in the **Shelving Time** field and selecting the increments from the units drop-down menu. You can also type the time directly into the field.
- 16. Enter the number of days that items are generally in transit from this location by clicking the up/down arrow buttons by the digit in the In Transit Days field and selecting the increments from the units drop-down menu.
- 17. Click **Finish** to save the settings or **Cancel** to discard them.
- 18. In the Locations dialog, click **Close**. This closes the dialog box.
- 19. In the Media Scheduling window, click **Close** to finish editing the policy group.

### NOTE:




Figure 2-37. Voyager System Administration Circulation - Cluster Maintenance




Figure 2-39. Media Scheduling - Policy Groups Locations setup

For the media equipment booking request form to display in WebVoyáge, the OPAC Circ Desk selection in Circulation - Cluster Maintenance (see <u>Figure 2-37</u>) must be included in the Media Scheduling - Policy Groups (see <u>Figure 2-38</u> and <u>Figure 2-39</u>).

You can make assignments for Room types, Equipment types and Item types. You can create new assignments, change existing ones and delete outdated ones.

The Room matrix allows you to specify what policy group should be applied to any room-related aspects of a transaction. This can be defined based on the Media Room Type and the patron group of the person submitting the request. You may create assignments for any combination of Room Types and patron groups. Rooms in Voyager Media Scheduling are assigned to a specific Media Room Type by setting the Room Type drop-down menu on the Details tab of the Room record in the Voyager Media Scheduling module.

The Equipment matrix allows you to specify what policy group should be applied to any equipment-related aspects of a transaction. This can be defined based on the Equipment Type and the patron group of the person submitting the request. You may create assignments for any combination of Equipment Types and patron groups. Equipment in Voyager Media Scheduling is assigned to a specific Equipment Type by setting the Equipment Type drop-down menu on the Details tab of the Equipment record in the Voyager Media Scheduling module.

The Item matrix allows you to specify what policy group should be applied to any item-related aspects of a transaction. (Items are the media added to a transaction on the **Media** tab of the request.) This can be defined based on the Media Type and the patron group of the person submitting the request. You may create

assignments for any combination of Media Types and patron groups. Media (i.e., items) in Voyager Media Scheduling are assigned to a specific Media Type by setting the Media Type drop-down menu of the item record (either through the Cataloging module or the Circulation module).

Assignments can be made to specific combinations of Patron Groups and Media/Media Room/Equipment Types or globally to all Patron Groups and/or all Media/Media Room/Equipment Types.




Figure 2-40. Policy Group Matrix Assignments-Room tab




Figure 2-41. Policy Group Rules - Patron Group Tab




Figure 2-42. Policy Group Rules - Room Tab




Figure 2-43. Policy Group Rules - Equipment Tab




Figure 2-44. Policy Group Rules - Media Tab




Figure 2-45. Media Types - Equipment List Dialog Box

# **Security Profiles and Policy Groups**



## Introduction

The security profiles and policy groups defiinitions determine operator authorization for the following:

- Viewing/processing equipment.
- Viewing/processing rooms.
- Viewing/processing items.

The following guidelines apply when setting these definitions.

- Locations always determine when a room or equipment can be viewed/ processed in.
- The policy group the operator is logged into must provide authorization to the same location as specified in the definitions in order to book an item, room, or equipment. Otherwise, the warning message "Item belongs to a foreign policy group" displays. This message can be overridden and the booking can be completed.
- When the location is not specified in both the and definitions, the operator cannot process inventory or book items, rooms, and equipment.

The following tables summarize the operator authorizations for the different combinations of settings in the Security Profiles and Policy Groups definitions.

- <u>Table A-1</u>contains information on Item Authorizations.
- <u>Table A-2</u>contains information on Room Authorizations.

• <u>Table A-3</u> contains information on Equipment Authorizations.
